When the RAMQ believes that a health care professional or a third party has demanded a payment from an insured person against the Health Insurance Act, while nothing in the regulations or agreements so permits, it reimburses the insured person the amount so paid and notifies the health care provider or the third party. The RAMQ will make such refund only if the insured person sends a demand, in writing, within one year of the date of the payment.
